**RE: Summary of CJAC Funding Recommendations for Plan Year 2023**

The CJAC met on March 30 to consider funding recommendations for the five grant categories that the Office of the Governor (OOG) requires CAPCOG to provide a funding recommendation for in addition to a score and rank:

- 1. General Victims Services (VC/VOCA);
- 2. Violence Against Women Justice and Training Program (WF/VAWA);
- 3. Truancy Prevention (TP);
- 4. Juvenile Justice (JJ); and
- 5. Criminal Justice Program (DJ/JAG).

Each applicant who presented to the CJAC was asked to identify a reduced funding request that they could accept and how that reduction would impact their program. Using this information, CAPCOG generated three initial options for the CJAC to consider for each grant category:

- 1. Full funding for all projects scoring at least 70.
- 2. Full funding for all projects scoring 85 – 100 and partial funding for projects scoring 70-85; and
- 3. Partial funding for all projects scoring 70 – 100.

For the WF/VAWA, TP, JJ, and DJ/JAG categories, the CJAC recommended option 1, while for the VC/VOCA category, they recommended option 2. The following table summarizes the total funding requested, total funding recommended, RBEs, and notes about the CJAC’s basis for the funding recommendation.

DJ/JAG	\$845,760.39 from 11 applications	\$669,260.39 for 9 applications; full funding for all projects scoring at least 70	\$743,530.31	Except for Travis County, full funding for all projects scoring at least 70. Travis County withdrew its application between its presentation and the March 30 <sup>th</sup> meeting and therefore was not recommended for funding. Another application scored below 70 and was therefore not recommended for funding. Note: Reduced funding would also affect future funding based on CAPCOG’s policies.

A few general notes:

- A total of 7 applications received a default score of “0” as a result of failure to attend one of CAPCOG’s mandatory grant writing workshops offered in December and January. \$763,403.21 was requested from 5 applicants in the VF/VAWA grant category.<sup>1</sup>
- The Office of the Governor (OOG) provided a Regional Budget Estimate (RBE) for this funding category of \$353,190.69, so total funding recommended exceeds the RBE, which is less than the total amount of funding recommended by the CJAC. However, the OOG also stated that “*CJACs are encouraged to recommend eligible projects beyond the RBE amounts shown below, in the event more funding becomes available.*” And in a phone conversation we had with OOG on 3/28, they indicated that the RBEs should not be the sole basis for a reduction in recommended funding for an application. For information purposes, the scoring/ranking tables does bracket which projects might be “on the bubble” for funding if

the RBE was all that was available, depending on the funding recommendation approach described above.
